MINUTES OF THE PRE-BID MEETING PROCUREMENT OF 2/3
WHEELERS AND FOUR WHEELER VEHICLES FOR CLARIFICATION &
MODIFICATION IN THE TENDER DOCUMENTS HELD ON 26-08-2014
AT 2:00 P.M.

A pre-bid meeting of 2/3 wheelers and four wheeler vehicles for clarification & modification in the Tender Documents was held on 26-08-2014 at 02:00 p.m. under the Chairmanship of Additional Secretary, (Admn) Excise, Taxation & Narcotics Department, Government of Sindh, Karachi. The list of participants is attached:-

Meeting started with recitation from the Holy Quran. Thereafter, the chair welcomed the participants / bidders and briefed about the whole criteria of Tender Document.

The following three (03) firms / companies have purchased / obtained Tender Documents for participation in the bidding for the subject procurement. They submitted various observations on Tender Document and also requested that the date of opening of Tender Bid may be extended. The date of opening was already extended upto 08-09-2014 and corrigendum had also been published in daily DAWN on 17-08-2014:

* The procurement committee appreciated the efforts in raising various queries which were also discussed in detail and approved as under:

1. Scope of Work

The word "Procurement" may be read instead of "Supply".

2. Specification of Number Plates.

Clause 2(vii) and Clause- 2(viii) in tender documents of 2/3 Wheelers and 04 (Four) Wheeler Vehicles the Manufacturing Tolerance is upto ± 3.00 mm for overall size of Number Plate and upto ± 0.3 mm in size of digits and alphabet.

Clause 2(ix) and Clause-2(x) in tender documents of 2/3 & 4 Wheelers Vehicles, the purity may be read as (99.3 - 100 %.)

Clause-2(xii) and (xiv) the word "Staving" may be read as "Stoving".

Clause-2(xiii) surface to be attached by using proper chemically may be read as "surface chemically treated".

Clause-3(d) in tender documents: Emblem of Govt. of Sindh; Screen Printed in green colour on the upper center of the plate may be read as under:

Emblem of Government of Sindh is screen printed with imported quality of Union Ink in National green colour.

Clause-4(v): Consignment of the number plates shall be provided from the date of issuance of contract as per given schedule in the contract may be read as under:

"Consignment of the finished number plates shall be provided by the manufacturer / successful bidder as per given schedule in the contract agreement by the department".

Clause-4(vii): The successful bidder will have to deposit @ 5% of the value of the contract price with the purchaser as performance security may be read as under:

" The successful bidder will have to deposit @ 5% of the contract price with the purchaser in the shape of Bank Guarantee".

Clause-4(xviii) Omitted.

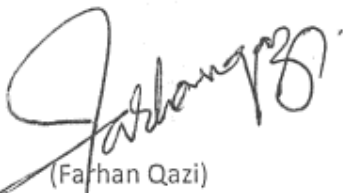
Clause-4(xiv) of tender document shall be replaced with Clause-5 as under:-

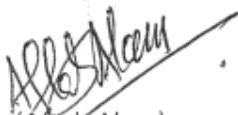

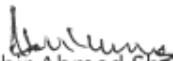
