Subject: **MINUTES OF MEETING HELD IN THE DIRECTORATE (ADMN/MVR), EXCISE, TAXATION & NARCOTICS CONTROL KARACHI ON 12.03.2019 AT 03:00 PM REGARDING REPORT OF TECHNICAL COMMITTEE FOR SUPPLY OF UNIFORMS & PROTECTIVE CLOTHING**

A meeting to discuss the report furnished by the Technical Committee was held in this Directorate on 12.03.2019 at 03:00 under the chairmanship of the Director (ADMN/MVR), Excise, Taxation & Narcotics Control, Karachi/Chairman Procurement Committee and was attended by all the five members (attendance sheet enclosed).

The meeting started with the recitation of Holy Quran. The chair welcomed the participants and apprised the significance of the meeting. Later, the chair asked the Secretary Procurement Committee/Chairman Technical Committee to read the report aloud and answer queries of the Chairman Procurement Committee and Mr. Khadim Hussain, Secretary Provincial Transport Authority, Transport & Mass Communication Department, Karachi, if any.

The Technical as well as Financial Proposal containing the signatures of members of Technical Committee was opened in front of all the Procurement Committee members which was sent by the Technical Committee vide letter No. DD/MR – ADMN/ESTT/1601 dated 28.02.2019; Mr. Waheed Shaikh started reading the report on point to point basis by comparing the rates as well as gauging the quality of material provided by the bidders as per criteria laid down in the RFP/bidding document and as per the criteria laid down in the Sindh Public Procurement Regulatory Authority, Rules 2010 (amended 2018), which is appended as under:

It was informed that the bid furnished by M/s IS Enterprises was out rightly rejected by the Procurement Committee for being not containing the Bid Security, which is termed mandatory as per bidding documents.

It was further informed that M/s Chand Engineering Works have failed to furnish Professional Tax Certificate and Financial Turnover for last three years in form of bank statement/certificate as well as the bid security which was less than the amount anticipated i.e. 2.5% of total bid; while M/s Waqas Enterprises haven't furnished Financial Turnover for last three years in form of bank statement/certificate, which are also termed mandatory in the RFP/bidding document.

After disqualification of M/s Waqas Enterprises and Chand Engineering Works for not submitting the required mandatory documents as per RFP/bidding documents the competition narrowed between two participants i.e. M/s Mohsin Enterprises and Shaheer Traders.

After having met the eligibility criteria, the two short listed firms mentioned were further examined in terms of per item price and quality of the stores. The findings thereof are appended hereunder:

As M/s Shaheer Traders being the first (1st) lowest priced bidder substantially responsive to all requirements of bidding documents having offered rates of **Rs. 4,397,360** (i.e. Rs. 9,994 per kit including all ten items) **for 440 kits** and the quality of uniform and liveries was also comparatively better than the other short listed participant i.e. Mohsin Enterprises, hence, **M/s Shaheer Traders** was recommended for further bidding process.

The Procurement Committee unanimously praised and agreed with the findings and recommendations of the Technical Committee and it was unanimously decided that the Bid Evaluation Report shall be hosted at PPMS/SPPRA website as termed mandatory before award of tender by the Competent Authority.

The meeting ended with a vote of thanks to and from the chair.



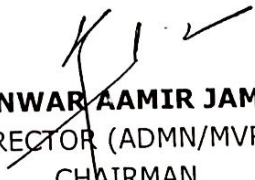

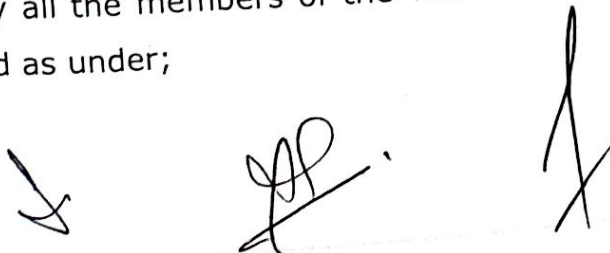
REPORT OF TECHNICAL COMMITTEE REGARDING EVALUATION OF TECHNICAL AS WELL AS FINANCIAL PROPOSALS SUBMITTED BY M/S MOHSIN ENTERPRISES, SHAHEER TRADERS, WAQAS ENTERPRISES, CHAND ENGINEERING WORKS & IS ENTERPRISES REGARDING SUPPLY OF UNIFORMS & PROTECTIVE CLOTHING

First (01st) meeting of the Technical Committee constituted vide letter No. DVR/MR(43)/Procurement/NP-TTS-U/2018-19/214 dated 30.01.2019 (Copy enclosed) and scope of which extended vide No. DVR/MR(43)/Procurement/NP-TTS-U/2018-19/216 dated 31.01.2019 (Copy enclosed) was convened on 19.02.2019 at 03:00 PM in the Directorate (ADMN/MVR), Excise, Taxation & Narcotics Control, Karachi vide No. DD/MR-ADMN/ESTT/1245 dated 15.02.2019 and was attended by all the members (attendance sheet enclosed).

The meeting started with the recitation of Holy Quran. The members were informed that the Chairman Procurement Committee sent the technical as well as financial proposals along with samples of Uniform kits vide Letter No. DVR/MR(43)/Procurement/NP-TTS-U-2018-19/233 dated 04.02.2019 submitted by M/s Mohsin Enterprises, Shaheer Traders, Waqas Enterprises, Chand Engineering Works & IS Enterprises for evaluation of technical as well as financial Proposals as per evaluation criteria laid down in the RFP/bidding document. The bid submitted by M/s IS Enterprises was rejected on technical grounds i.e. they did not submit the pay order of bid security/Earnest Money along with the technical and financial proposal which was mandatory as in NIT and also in clause (C) which is reproduced as under;

"Earnest money in shape of pay order in favour of Director (Admn/MVR) Excise, Taxation & Narcotics Control Karachi will have to be submitted along with tender document @ 2.5%"

Following the parameters in the evaluation criteria for the bidders as described in the Bidding Document/RFP, the bidding documents were scrutinized in detail by all the members of the Technical Committee and a consolidated statement is enclosed as under;

Further M/s Chand Engineering Works did not submit the certificate of professional tax and financial turnover for last three years (bank statement/certificate) and the firm has given less amount of bid security i.e. 2.5% of total bid being mandatory document as per RFP/bid document and M/s Waqas Enterprises did not submit the financial turnover for last three years (bank statement/certificate) being mandatory document; so, all the members did not consider both the participating bidders i.e. M/s Chand Engineering Works and M/s Waqas Enterprises for further bidding processes. Whereas, after rejection of M/s Chand Engineering Works and M/s Waqas Enterprises the tabulation/competition of both eligible companies reflects as under:
